Part I: Definitions

- a. CRGCS includes the Association, its directors, agents, members, and all persons or bodies corporate lawfully in attendance at CRGCS activities defined in b. below or engaged on the Association’s behalf.
- b. CRGCS activities are all lawful activities engaged in by CRGCS, or by any person, at CRGCS events, facilities or premises, including record keeping, the organization and hosting of instructional programs, sporting and social events, the discharge, loading, maintenance, transportation, storage and general use of ammunition, firearms and other projectile devices including archery and air-guns; the operation of a clubhouse and outbuildings, maintenance equipment and facilities, roads, shooting and target ranges, the construction, maintenance, or removal of any of the foregoing, landscaping of the premises or wildlife management.

Part II: Acknowledgements

- a. The undersigned Releasor acknowledges that engaging in CRGCS activities or being present at CRGCS events, facilities or premises entails risk of bodily harm or death resulting from accidental shootings, misfires, ricochets, fire, vehicular accident, animal attack, the operation of heavy equipment, toxic contaminants, and the negligent or willful unlawful conduct of any person.
- b. The undersigned Releasor acknowledges that he or she has the right to independent legal advice prior to executing this waiver and indemnity agreement.
- c. The undersigned Releasor hereby acknowledges and agrees to abide by all laws of Canada and of the Province of British Columbia relevant to CRGCS activities, all rules of CRGCS, and all safety procedures advised or mandated by CRGCS, while participating in CRGCS activities or when in attendance at CRGCS events, facilities, or premises.
- d. The undersigned Releasor acknowledges and agrees that this Agreement is binding upon his or her own person and estate, successors, and assigns, and acknowledges that he or she has read and understands this Agreement.
- e. The undersigned Releasor acknowledges and expressly agrees that his or her participation in CRGCS activities or attendance at CRGCS events, facilities or premises is conditional upon entering into this agreement.
- f. This Agreement shall be governed by the laws of the Province of British Columbia.

Part III: Consideration, Waiver & Indemnity

- a. In consideration of CRGCS granting and licensing to the undersigned Releasor the right to participate in CRGCS activities, or to attend at CRGCS events, facilities, or premises, the Releasor, freely and voluntarily, does hereby provide the waiver & indemnity set out in this part.
- b. *Exclusion of Liability [Waiver]:* The undersigned Releasor hereby releases and agrees to save harmless CRGCS from any claim or cause of action in contract, negligence or otherwise, arising from or relating to participation in CRGCS activities, or attendance at CRGCS events, facilities or premises, and forever waives all right to same.
- c. *Indemnity:* The undersigned Releasor hereby agrees to indemnify [repay and make whole] CRGCS for liability for damage, loss or injury to any third party resulting from the Releasor’s own actions during participation in CRGCS activities or attendance at CRGCS events, facilities, or premises.

Part IV: Consent

- a. The undersigned Releasor consents to the collection, storage and use by CRGCS of all personal information related to and required for CRGCS activities.
